## Enhanced Proliferation Control Initiative ("EPCI") End Use Form



The U.S. Department of Commerce's Bureau of Industry and Security ("BIS") imposes requirements on exporters to ensure that items being exported are not destined for an improper end use or undesirable end-user, as defined in BIS regulations. - We will not sell, otherwise transfer or re-export any Covestro product or any direct product thereof contrary to U.S. law.
- We will not use Covestro product nor the direct product thereof in any sensitive nuclear end
  uses, including nuclear explosive activities, unsafeguarded nuclear activities related to any
  nuclear reactor, critical facility, facility for the fabrication for nuclear fuel, facility for the
  conversion of nuclear material from one chemical form to another or separate storage
  installation, where there is no obligation to accept a International Atomic Energy Agency
  (IAEA) safeguards, and safeguarded and unsafeguarded nuclear fuel cycle activites.
- We will not use Covestro product nor the direct product thereof for activities related to chemical or biological weapon research, design, development, production, testing, stockpiling, sale, installation, operation, maintenance or use.
- We will not use Covestro product nor the direct product thereof for activities or research related to missile research, design, development, production, testing, stockpiling, sale, installation, maintenance, operation or use (the term 'missiles' includes but is not limited to rockets and unmanned air vehicle systems) in or by one of the following countries: Bahrain, China, Egypt, Iran, Iraq, Israel, Jordan, North Korea, Kuwait, Lebanon, Libya, Macau, Oman, Pakistan, Qatar, Saudi Arabia, Syria, United Arab Emirates or Yemen.
- We will not knowingly re-sell, re-export or transfer Covestro product nor the direct product thereof to entities involved in any of the above-mentioned activities.
