- Sales decreased by 12.0% Y/Y to €3,171m with volume -1.5%, price -7.0%, FX -3.5%
- EBITDA decreased to €242m (Q3'24: €287m) driven by volume effect of €-17m, pricing delta of €-102m, FX of €-14m and others of €+88m, mainly driven by structural cost savings (STRONG) and by cost contingencies

Solutions & Specialties

- Sales decreased by 7.7% Y/Y to €1,637m with volume +0.4%, price -4.3%, FX -3.8%
- EBITDA of €196m (Q3'24: €208m) driven by negative pricing delta and FX while positive others and volumes

Others/Consolidation

• EBITDA of €-128m (Q3'24: €-46m) including €-75m from group-neutral captive insurance reimbursement
